#### The Annual FILIA meeting was held Saturday June 15

The guest speaker presented information about a Lake Improvement District (L.I.D.). The FILIA board is investigating how a Lake Improvement District (LID) works. There is still a lot of information to be gathered and

conveyed to the property owners, and president Cindy Chuhanic asked that property owners help by doing their own research – the more we know the better. A lot of information can be found online. As your board it is our responsibility to look into problems that other lakes are having, so if it happens here, we know what to do.

A LID is a local governmental unit managed by a local board of directors (BOD), not the FILIA BOD, that has taxing authority. A LID can be formed only with a resolution of the Aitkin County board and the approval of at least 60% of Farm Island Lake (FIL) property owners.

Some of the reasons that the FILIA Board is looking into a Lake Improvement District is:

- 1. The cost of treating an aquatic invasive species such as Zebra Mussels, Eurasian Milfoil or new species.
- 2. To have a steady source of funds for ongoing lake improvement.
- 3. With the formation of a Lake Improvement District, all property owners will share in the cost of the stewardship of Farm Island Lake. Past membership has shown that less than half support the lake association, out of the approximately 360 FIL property owners.

Greg Anderson announced this is his last year as a board member, so we will have an opening next year.


# **2018 AIS Inspection Final Results**

- Greg Anderson and Bill Haroldson created and presented a PowerPoint report on the 2018 AIS

- Approximately 20 boat landings throughout Aitkin County had inspectors present in 2018. ...Of the 250 AIS issues, 155 of them were for drain plugs still in the boat upon arrival, 94 were plants, water, mud, etc. on the boat or trailer. Once again, the busiest lake was Farm Island, with Big Sandy coming in 2nd, and Cedar in 3rd. A chart and information is in the full report, which can be found on the FILIA website.



There were no zebra mussels found in Farm Island Lake. They have been found in Bay Lake and Big Pine, so they are a near and present threat to Farm Island Lake.

**The DNR AIS program** addresses invasive species in Minnesota, such as Eurasian watermilfoil, purple loosestrife, zebra mussel, spiny water flea and starry stonewort. Efforts in this area include working to prevent further spread and to manage impacts from invasive populations. #### Minnesota law requires water recreationists to:

- Clean watercraft of all aquatic plants and prohibited invasive species.
- **Drain** all water by removing drain plugs and keeping them out during transport.
- **Dispose** of unwanted bait in the trash and dispose of bait water.
- **Dry** docks, lifts, swim rafts and other equipment for at least 21 days before placing equipment into another water body.

## Hooked? What to do if you get "caught" up in all the fun



Article from Independent Age published June 12, 2019

A common injury for those who fish or just hang out near docks and boats is becoming "hooked" when the intended catch was a fish. The medical team at Essentia Health recommends removing the fish hook from your finger using the String Yank Technique.

- 1. Remove hook from lure by cutting at attachment ring.
- 2. Tape any additional free hooks to prevent the hooks from also getting embedded.3. First, wash your hands with soap and water, or disinfecting solution, and then wash the area surrounding the hook.
- 4. Tie off a loop with some fishing line. Read more steps .....

We do not recommend pushing the hook through your skin and cutting the barb as this introduces another potential wound for infection. Also, do not try to remove a fish hook that is deeply embedded in the skin, lodged within a joint or tendon, or located in or near an eye or artery. If you are at all unsure, it is best to seek medical attention immediately.

# A cool \$100

Article from Independent Age published June 12, 2019

County offers a \$100 reward to those who leave these items out of the water for 30 days. Between June 1 and Nov. 30, Aitkin County is offering an incentive to combat the spread of aquatic invasive species. According to state law, docks or boat lifts must be out of the water for 21 days before they are moved to another body of water or sold. A new program through Aitkin County offers a \$100 reward to those who leave these items out of the water for 30 days.

Aitkin County started a program June 1 especially for movers or sellers of docks and boat lifts. Since July 2012, Minnesota law states that any boat lift, dock, swim raft, or associated equipment that has been removed from any water body may not be placed in another water body until a minimum of 21 days have passed. Now people moving or selling those items can be rewarded \$100 just for leaving a dock or boat lift out for nine extra days for a total of 30 days on land (the dock or boat lift must have been in the

water in the current open water season). The program runs each year from June 1 through Nov. 30. Read more....



# SCUBA Warning Flag A diver down flag, or scuba flag, is a flag used on the water to indicate that there is a diver below. This flag will also be displayed on the diver's boat. All vessels, boats, jet skis, etc. should stay at least 200 feet away when they see a SCUBA flag.

# Clean In Clean Out

When boating or fishing in Minnesota, protect your waters by following state aquatic invasive species laws.

- 1. CLEAN all visible aquatic plants, zebra mussels, and other prohibited invasive species from watercraft, trailers, and water-related equipment before leaving any water access or shoreland.
- **2. DRAIN** water-related equipment (boat, ballast tanks, portable bait containers, motor) *and* drain bilge, live well and baitwell by removing drain plugs before leaving a water access or shoreline property. **Keep drain plugs out** and water-draining devices open while transporting watercraft.

**3. DISPOSE** of unwanted bait, including minnows, leeches, and worms, in the trash. It is illegal to release bait into a waterbody or release aquatic animals from one waterbody to another. If you want to keep your bait, you must refill the bait container with bottled or tap water.

# KNOW THE LAW: You may not...

- Transport watercraft without removing the drain plug.
- Arrive at lake access with drain plug in place.
- Transport aquatic plants, zebra mussels, or other prohibited species on any roadway.
- Launch a watercraft with prohibited species attached.
- Transport water from Minnesota lakes or rivers.
- Release bait into the water.

#### ADDITIONAL RECOMMENDATIONS

Spray, rinse, dry — Some invasive species are small and difficult to see at the access. To remove or kill them, take one or more of the following precautions before moving to another waterbody, especially after leaving zebra mussel and spiny waterflea infested waters:

- Spray with high-pressure water
- Rinse with very hot water\*
- Dry for at least 5 days

Run motor and personal watercraft for a few seconds to discharge water before leaving a water access.

Transport fish on ice — be prepared, bring a cooler.

\* These water temperatures will kill zebra mussels and some other AIS: 120°F for at least 2 minutes; or 140°F for at least 10 seconds

#### **Report suspicious infestations**

If you suspect a new infestation of an invasive plant or animal, take a photo and note the location, or save a specimen and report it to a local <u>DNR invasive species contact</u>.
